Fisheries Reports for November 2018 by Dean Hawkins

Good evening everyone, you will be glad to hear that my report this month is very short in comparison to the last two months.

I can confirm that the car park and pathway on our Snargate fishery has been cut within the last week. I have since spoken with the owners of the Post Office/Stores in Appledore, and they have said they would be happy to sell day tickets for the fishery and display a poster in the window advertising the fishery, for a nominal fee. Because the poster would be in the window indefinitely, it would not incur the normal weekly charge, it would be based on an acceptable donation made to their chosen charity by CALPAC.

Should we decide to go ahead with this, I would then design and print the poster, I would also need to get a new sign made for the fishery detailing where the day tickets can be purchased.

I have sent out the works contract for Padworth to be signed, I am now waiting for it to be returned to me. I have also spoken recently to Adam Hilliard (EA) about the Barbel and Chub which are to be stocked, he said he will find out this month how many we are to receive from Calverton. Depending on flow levels, the fish will either be stocked into the southern channel or the aquarium swim on the main river.

I will need to order another 5L of the Gallup 360 weed killer and a roll of 2.4mm strimmer line soon, with an approximate cost of £40 for both items. I will also book the Honda Versatool in for a service soon. I think last year that cost about £35.
